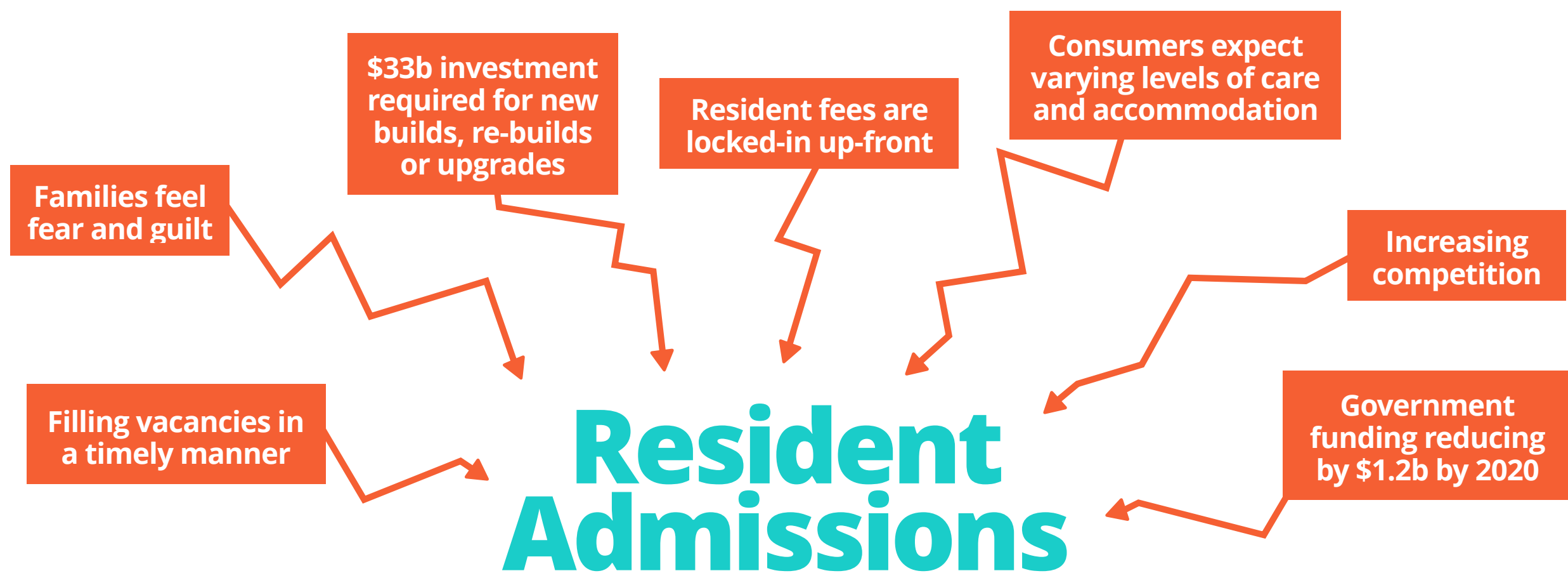

The Aged Care admissions process is under sustained pressure from various conflicting stakeholders



Australian Aged Care Providers have to make a complex, business-critical decision every time a vacancy is created. These vacancies need to be filled in a timely manner as soon as a resident departs, an event that is often unpredictable.

Under this time pressure and given an available care and accommodation package, Providers have to somehow work out the best match from a waiting list of potential residents each with varying needs and expectations.

On the other hand, for consumers and their families, **the admissions process can be highly charged with emotions of fear and guilt**. Collecting payments up front only adds to this pressure.

This decision is as significant for the resident as it is for the Provider but for different reasons. **The resident fee structure consists of flexible options between a lump sum and daily payments**, there is a corresponding impact on operational cash flow as well as long-term capital expenditure.

ACFA estimates that **the industry needs to spend \$33b on builds, rebuilds and upgrades over the next 10 to 15 years¹** to support the growth in aged care demand, setting the right resident fee structure is critical to financial success.

Given the process is high-stakes, how are you supporting your team to make the right decisions?

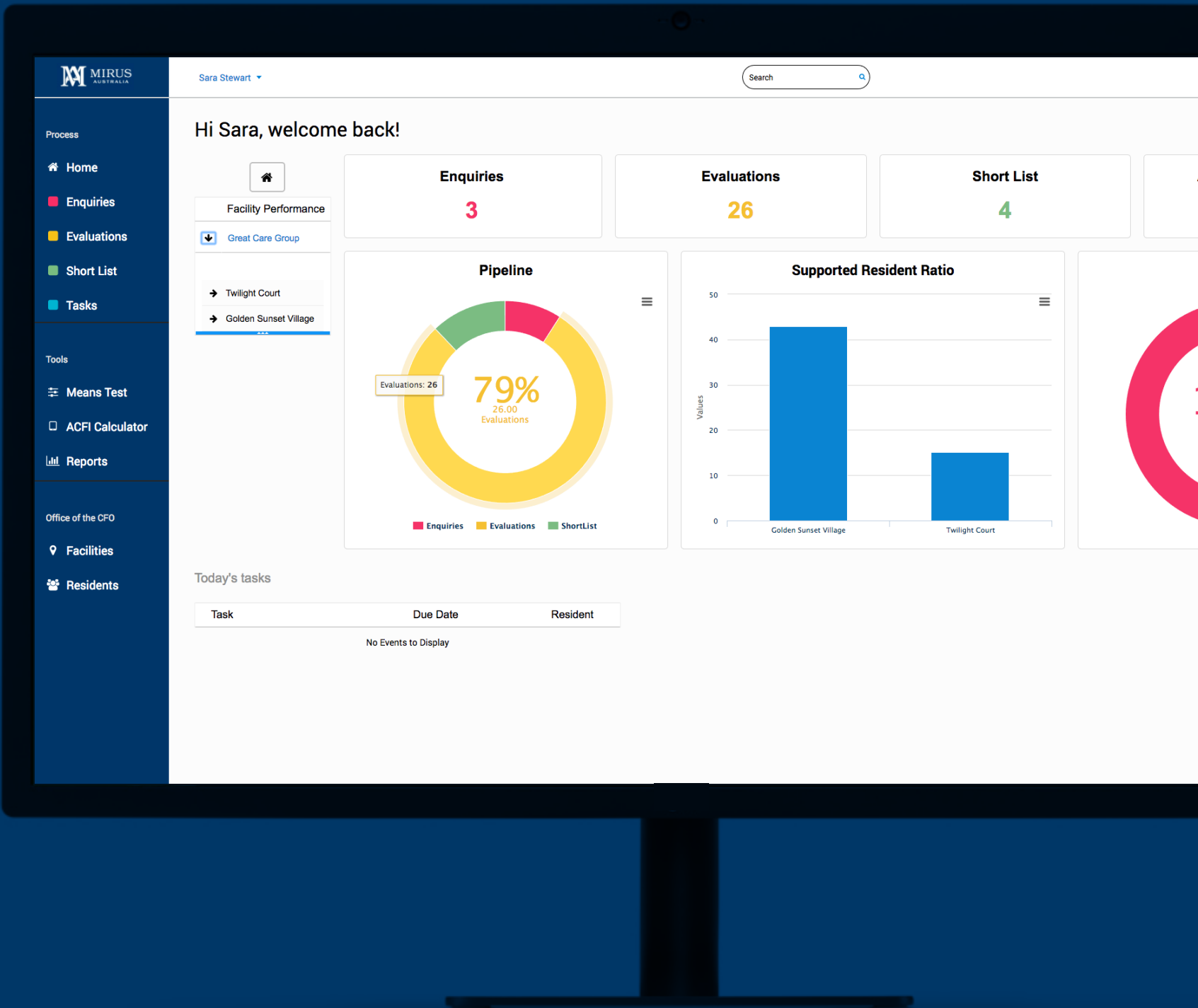
