

Total care minutes increased from October to November by 1.53 percent while Registered Nurse minutes per resident per day increased 1.24 percent. Average Daily Subsidy decreased -\$0.16, which meant the industry average resident casemix reduced from 203.61 to 203.43.

Minutes are measured as the actual worked minutes based on time and attendance and averaged across the number of days in the month and the total number of resident bed days for the month. Average Daily Subsidy is the average subsidy entitlement for all residents including respite but excluding defaults. Assessment activity is based on AMO assessment activity that eventuates in a paid AN-ACC claim based on the entitlement start date. Because the AN-ACC start date is back dated to an effective date prior to the actual assessment the current month's activity will almost always be lower than the previous month.



Occupancy continues to make slight gains, likely limited by the corresponding impact additional residents place on the roster requirement.
