

Under Embargo until 20 Feb 2024

Total care minutes rebounded from a December holiday dip, increasing 1.47%, while RN time added over a minute per resident per day or 3.27%. This increase is not quite back to the high point measured in November 2023 of 205.11. Average Daily Subsidy edged higher, and occupancy slid back slightly, however, essentially unchanged when seasonally adjusted.

Minutes are measured as the actual worked minutes based on time and attendance and averaged across the number of days in the month and the total number of resident bed days for the month. Average Daily Subsidy is the average subsidy entitlement for all residents including respite but excluding defaults. Assessment activity is based on AMO assessment activity that eventuates in a paid AN-ACC claim based on the entitlement start date. Because the AN-ACC start date is back dated to an effective date prior to the actual assessment the current month's activity will almost always be lower than the previous month.

By design of the AN-ACC model the average resident casemix matched the increase to ADS moving up from 204.02 to 204.11.
